Tempus NitroLOCK decreases nitrogen loss from volatility, nitrification, and leaching, while increasing soil ammonium levels when applied with nitrogen at the recommended label rate. The calcium polymer technology is non-corrosive and has no planting restrictions, does not kill beneficial soil bacteria, and manages nitrogen to be in the ammonium form longer into the season.

DIRECTIONS FOR USE

Consult your certified crop consultant for recommendations.

ANHYDROUS AMMONIA: 6 ounces per 50 units of Nitrogen

LIQUID UAN SOLUTION: 2 quarts of Tempus NitroLOCK per ton of UAN

LIQUID MANURE: 24 ounces to 32 ounces per acre

Tempus NitroLOCK may be used with any crop and in any soil type where best management practices call for the addition of nitrogen fertilizers.

FIRST AID

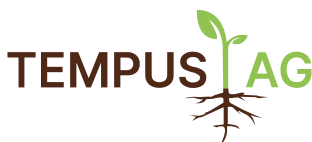
